CONDITIONS AND RESTRICTIONS:

- Subject to the conditions, restrictions, and approval, this permit for the transportation of overweight and/or oversize equipment listed above has been issued for the movement on select Kalamazoo County Road Commission Roads.
- The permittee shall be responsible for damages to the highway, to persons, and to property caused by, or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Kalamazoo County Road Commission and all of their employees from any and all suits, claims, and damages of every kind arising out of, under, or by reason of this permit, or from operations covered by this permit.

If a permit is granted, the applicant agrees to comply with all the conditions and restrictions listed on this application and contained in the Board's Policy: construct, operate, maintain, use and/or remove within the County Road right-of-way.

ANNUAL CAB CARD PERMIT RULES AND REGULATIONS

1. The driver of the vehicle shall carry a permit cab card in the vehicle to which it applies and shall have it available for inspection by any police officer or agent of the Kalamazoo County Road Commission or Michigan Public Service Commission.
2. No such involvement will be allowed between sundown and sunrise, or on a Saturday, Sunday, or holidays, or any time when weather, road, or traffic conditions create potentially hazardous conditions, unless specifically approved by the Commission.
3. The movement shall not impede other traffic in an unreasonable manner and at no time shall other traffic be blocked from use of the highway. Vehicles and loads shall not be parked on the highway day or night.
4. Applicant shall be responsible for any damages caused to wires, mailboxes, and trees on the highway, and shall reimburse the owners or persons in charge for any property damage caused by the moving of said vehicle or load, and shall save harmless and indemnify the Kalamazoo County Road Commission from all suits, claims, damages, and proceedings of the every kind arising out of the presence on an use of the highway by said vehicle and load.
5. The speed of the vehicle and load shall not exceed that shown on this permit.
6. Vehicles shall be registered as required by the Michigan statutes and will not violate any statute or valid ordinance, rule, or regulation by any state agency or sub-division of the state. Vehicles are to comply with all statutory provisions as to other permits, licensing, motor vehicle equipment, and operation.
7. Permits will in no way supersede posted axle loading limits on any bridge, culvert, or roadway. The applicant agrees to reimburse the Kalamazoo County Road Commission for any damage resulting from the disregard of such postings.
8. The equipment shall be loaded on the vehicle in such a manner to reduce to a minimum the excess over statutory size or weight limitations and the least width or length dimensions becomes the width of the load.
9. The ball or bucket is to be removed on cranes or draglines. The boom is to be securely fastened to the frame of the truck while in transit.
10. The vehicle shall not be loaded or unloaded within the outer shoulder limits of any county road.
11. The Board may suspend the Annual Cab Card Permit temporarily, either in its entirety or in respect to certain of its provisions, due to seasonal or other special conditions.
12. Permits are invalidated automatically by the violation of any of the conditions specified by the terms of the permit or by false information given on the application. Failure to comply with the conditions of this permit shall be just cause for the immediate suspension or revocation of any or all permits and the operator and/or owner of the vehicle subject to arrest.
13. All moves shall be flagged properly with clean red or orange flags having a minimum dimension of no less than 18" square.
14. The applicant shall submit a certificate of insurance showing insurance coverage is in effect. Liability coverage - \$1,000,000. Certificate of Insurance must contain the following language: "Additional insured with regard to Liability Coverage: The Kalamazoo County Road Commission, its agents, officers, board members, and employees located at 3801 East Kilgore Road, Kalamazoo, MI 49001."
15. PERMIT NOT VALID when spring load limitations are in force, or at any time road, weather, or traffic conditions make travel unsafe; or if the following dimensions or loads are exceeded:
